

## **Data Protection Information Event Photos and Videos**

At Fraunhofer FHR's Wissenschaftscampus – women in THz on June 6, 2024, photos and videos will be taken at the different event sites to document the event. It cannot be ruled out that it might be possible to directly or indirectly identify you in these images. Therefore, these images are personal data in terms of the General Data Protection Regulation (GDPR).

Below you will find information about how we process these images, which purposes we process them for, how long we process for, and what your rights are in relation to this.

The images will be created for Fraunhofer or its **Fraunhofer FHR** and used for news directly relating to the event as well as for internal reporting purposes at Fraunhofer. In addition, the images might also be used for reporting during the event and on our media platforms such as Facebook, Twitter, Instagram, LinkedIn, YouTube, and similar as well as on our websites after the event. In particular, this processing is necessary to document and promote our event.

The data processing will be based on Art. 6 Section 1 S. 1 lit. f GDPR. The purposes mentioned are legitimate interests as per this provision.

In principle, the images will be saved for a maximum of 5 years. Individual exceptional photos might be saved for a longer period to document the institute's history.

### **You have the right to:**

- obtain access to the personal data we process about you according to Article 15 GDPR;
- obtain without undue delay the rectification or completion of the personal data we have saved about you according to Art. 16 GDPR;
- obtain the erasure of the personal data we have saved about you according to Art. 17 GDPR to the extent that the processing is not necessary for exercising the right of freedom of expression and information, for the compliance with a legal obligation, for reasons of public interests, or for the establishment, exercise, or defense of legal claims;
- obtain the restriction of processing of your personal data according to Art. 18 GDPR where you contest the accuracy of the data, the processing is unlawful and you oppose the erasure of the personal data, and we no longer need the data but you require them for the establishment, exercise, or defense of legal claims, or you have objected to the processing pursuant to Art. 21 GDPR;
- file a complaint with a supervisory authority according to Art. 77 GDPR. To do this, you can generally contact the supervisory authority of your habitual residence, place of work, or our society's office.

### **Right to object**

You have the right to object to the processing of your personal data according to Art. 21 GDPR if there are grounds relating to your particular situation. Your data will then no longer be processed unless the organizer can demonstrate compelling grounds for the processing which override the interests, rights, and freedoms of the data subject or for the establishment, exercise, or defense of legal claims.
